Dear Parents and Guardians,

We are excited to introduce our new youth dodgeball league! The program is open for youth aged 4-12, and will run for one hour every Thursday night at 5:30pm. Younger participants will focus on movement skills, catching and throwing, while older participants will incorporate dodgeball strategies and play a number of regulation dodgeball games. As always, sportsmanship and having fun will be cornerstones of the program.

Fee: \$60/ participant

In an effort to have the program run smoothly, we have set up the following guidelines for parents and players:

- Due to supervision concerns, you are asked to bring your child to practice no more than **10 minutes** prior to their start time. Please ensure that you pick up your child promptly at the end of practice. ***Children will not be allowed to hang out in the building following their session.***
- Soccer players should come to the venue already dressed in their gear. Soccer gear includes: shorts or sweatpants, t-shirt or soccer jersey and indoor, non-marking running shoes.
- We ask that everyone respect the venue. Please place garbage in the appropriate containers and ensure that your children remain in designated areas only.
- Outdoor gear is not allowed in the gym. Boots will have to be left in the entrance area of the venue. This will avoid having wet, slippery, dirty or dangerous debris on the playing area.
- Food and drinks will not be allowed in the gym on the playing surface; players should bring their own water bottle with their name clearly marked on it and ***filled with water only.***

The City of Iqaluit Minor Soccer Program (“Minor Soccer”) strives to provide a safe, clean and fun atmosphere.

In Consideration of my child’s voluntary participation in the Minor dodgeball league in Iqaluit, Nunavut, including all Minor Dodgeball planned throughout the City of Iqaluit, I acknowledge and agree on behalf of myself and my child identified above that:

1. The risk of serious injury from participating in the Minor Soccer Activities, although minimal, does exist;
2. My child is physically fit to participate in the Minor Soccer and I agree that all Minor Soccer Activities are appropriate for my child;
3. I, for myself and my child, knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the City of Iqaluit and assume full responsibility for my child’s participation at the Camp;
4. I and my child willingly agree to comply with the stated Terms and Conditions for participation and to obey the direction and requests of the City of Iqaluit staff. If I observe any hazards during my presence or my child’s participation, I will remove myself and my child from the participation and immediately bring the said hazard to the attention of the nearest City of Iqaluit **Recreation Department** Employee;
5. I, for myself, my child and on behalf of my heirs, assigns, personal representatives, insurers and next of kin, **HEREBY WAIVE, RELEASE, AND HOLD HARMLESS**, the City of Iqaluit and its agents, employees, volunteers, officers and directors (collectively the “City of Iqaluit”) from any and all claims, demands, lawsuits, actions, causes of action, complaints, litigation, costs (including legal costs or fees) or liabilities arising out of, or in any way related to, any loss, damage, expense or injury (whether to person or property) that I or my child may suffer as a result of my child’s participation in the Minor Soccer, due to any cause whatsoever;

I **AGREE TO HOLD HARMLESS AND INDEMNIFY** the City of Iqaluit from any and all claims, demands, lawsuits, actions, causes of action, complaints, litigation, expenses, costs (including legal costs or fees) or damages (whether to person or property), of any kind or nature whatsoever, that they might suffer or incur arising out of or in any way related to my minor child’s involvement or participation in the Minor Soccer; and

This release and waiver extends to all acts of negligence by the City of Iqaluit and is intended to be as broad and inclusive as permitted by the laws of the Nunavut Territory, and of Canada as applied in Nunavut, and if any portion of the agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
