Dear Parents and Guardians,

We are offering a second session of Lil' Sluggers Tee Ball for the summer of 2018! We will split the time between the curling rink and the Federal Road Ball diamond. Please see the breakdown below. For the last session on August 8<sup>th</sup> we will host a BBQ. Parents are invited to come play catch with their kids while the coaches cook to finish of a great season of Tee Ball.

**Wednesdays from:**

**July 11th to August 8th**

5:30-6:30 (Ages 4-8)

July 11, 18 & 25 at the curling rink.

August 1<sup>st</sup> & 8<sup>th</sup> all the Federal Road Ball Diamond. (Weather permitting)

In an effort to have the program run smoothly, we have set up the following guidelines for parents and players:

- Due to supervision concerns, you are asked to bring your child to practice no more than **10 minutes** prior to their start time. Please ensure that you pick up your child promptly at the end of practice. ***Children will not be allowed to hang out at the curling rink following their tee-ball practice.***
- Tee-ball players should come to the venue with running shoes. No other equipment is required, though youth are encouraged to bring their own should they possess it. Only Tee-Balls (Sof-Tee's) and wiffle balls will be used.
- We ask that everyone respect the venue. Please place garbage in the appropriate containers and ensure that your children remain in designated areas only.
- Wet and/or muddy footwear will have to be left in the entrance area of the venue. This will avoid having wet, slippery, dirty or dangerous debris on the playing area.
- Food and drinks will not be allowed on the playing surface; players should bring their own water bottle with their name clearly marked on it and ***filled with water only***. Food and drinks are to be had in the lobby.

The City of Iqaluit Lil' Sluggers ("Tee-Ball") strives to provide a safe, clean and fun atmosphere.

In Consideration of my child's voluntary participation in the Iqaluit Lil' Sluggers in Iqaluit, Nunavut, including all Tee-Ball planned throughout the City of Iqaluit, I acknowledge and agree on behalf of myself and my child identified above that:

1. The risk of serious injury from participating in the Tee-Ball Activities, although minimal, does exist;
2. My child is physically fit to participate in Tee-Ball and I agree that all Tee-Ball Activities are appropriate for my child;
3. I, for myself and my child, knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the City of Iqaluit and assume full responsibility for my child's participation in the league;
4. I and my child willingly agree to comply with the stated Terms and Conditions for participation and to obey the direction and requests of the City of Iqaluit staff. If I observe any hazards during my presence or my child's participation, I will remove myself and my child from the participation and immediately bring the said hazard to the attention of the nearest City of Iqaluit **Recreation Department** Employee;
5. I, for myself, my child and on behalf of my heirs, assigns, personal representatives, insurers and next of kin, HEREBY WAIVE, RELEASE, AND HOLD HARMLESS, the City of Iqaluit and its agents, employees, volunteers, officers and directors (collectively the "City of Iqaluit") from any and all claims, demands, lawsuits, actions, causes of action, complaints, litigation, costs (including legal costs or fees) or liabilities arising out of, or in any way related to, any loss, damage, expense or injury (whether to person or property) that I or my child may suffer as a result of my child's participation in Tee-Ball, due to any cause whatsoever;
6. I AGREE TO HOLD HARMLESS AND INDEMNIFY the City of Iqaluit from any and all claims, demands, lawsuits, actions, causes of action, complaints, litigation, expenses, costs (including legal costs or fees) or damages (whether to person or property), of any kind or nature whatsoever, that they might suffer or incur arising out of or in any way related to my minor child's involvement or participation Tee-Ball; and

This release and waiver extends to all acts of negligence by the City of Iqaluit and is intended to be as broad and inclusive as permitted by the laws of the Nunavut Territory, and of Canada as applied in Nunavut, and if any portion of the agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
